Information needed to apply for a property:

 - If you turn in application fees and your credit is not run, the fees become non-refundable after 30 days.
 - The fee is not required to be paid until the applicant(s) have viewed the property.
- 3. Income verification: Provide the last two pay stubs for all applicants whose income is to be considered to rent the property. If you have questions on other forms of income verification, please call 928-220-9062.
